The goal of CMS"s TCPI Initiative is to enable large scale clinician transformation in order to deliver better care that will result in better health outcomes at lower costs. CMS is supporting 30 Practice Transformation Network (PTNs) nationally by creating peer-based learning networks designed to coach, mentor, and assist clinicians in developing core competencies specific to practice transformation. HealthPartners Delmarva (HPD)

HealthPartners Delmarva is the Practice Transformation Network supporting ED clinicians in the State of DE, MD and VA. As a participating physician in this pilot, you will be working with HealthPartners Delmarva who will be leading this CMS funded project. You will be supported by the HPD team which is responsible for facilitating the transformation process. Practices can expect to participate in Healthcare Communities, CMS's collaborative social network and will receive targeted site visits, semi-annual collaborative meetings in collaboration with ACEP as well as regular practice emails and conference calls. While this project is measured by the number of clinicians that are impacted by this program, in reality, it is the multi-disciplinary process improvement teams that will be leveraged to lead change within the practice and across the communities.

Rhode Island Practice Transformation Network

The Rhode Island Practice Transformation Network, a service of the Rhode Island Quality Institute, is offering customized practice transformation assistance to emergency department (ED) clinicians to prepare them for upcoming changes to reimbursement both at the federal (Centers for Medicare & Medicaid Services) and local (Medicaid and commercial payer) levels. These changes are part of several initiatives to move from volume to value based payment. The RI PTN will provide workflow redesign assistance, help in using data to inform clinical and business decisions and to improve population health, care management and care transitions training, approaches to encourage patient and caregiver engagement, and strategies to collaborate with both primary and specialty care clinicians. A practice facilitator will be assigned to assess your ED, identify quality improvement needs, and work out a plan to accomplish your goals. Southern New England Practice Transformation Network

The Southern New England Practice Transformation Network (SNE-PTN) seeks to engage Emergency Medicine physicians in this CMS-funded program. There is no cost for physicians to participate. All Massachusetts and Connecticut physicians who do not participate in a Medicare shared savings ACO are eligible. We collaborate with ACEP to help Emergency Physicians achieve the Triple Aim: better care, better health, and lower costs. The over-arching goal is to facilitate success as payment reform rapidly advances. Increasingly, re-imbursement will be tied to quality and efficiency, thus creating a compelling case to improve health care delivery.

SNE-PTN provides a Quality Improvement Advisor, who will visit sites and guide clinicians through QI activities to achieve their goals, using a customized approach of consultation and guidance to meet clinicians where they are – and help them achieve their specific strategic aims. Participants get free resources to help support practice transformation, which might include optimization of care delivery, data management, behavioral health integration, and coordination of care throughout the "medical neighborhood." SNE-PTN helps sites develop well-functioning multidisciplinary care teams, optimize workflows, and enhance EMR functionality so that physicians will have the time to do what they were trained to do: take care of patients.
