The panelists explained that in cases where a higher MDM level is desired, providers should consider citing the electrocardiogram (ECG) as the procedure to justify the increase while still billing the ultrasound separately. This strategy allows for optimal billing without sacrificing the separate reimbursement for the ultrasound procedure.

By billing the ultrasound separately, providers can ensure that the procedure is not "lost" in the overall E/M code, maintaining the visibility and value of this essential diagnostic tool. This approach also allows for more accurate tracking of ultrasound utilization and can help demonstrate the importance of ultrasound programs in emergency medicine.

Furthermore, using the ECG to justify a higher MDM level is a sound strategy, as ECGs are commonly performed in emergency department settings and can provide valuable diagnostic information. By leveraging the ECG to support a higher level of medical decision-making, providers can optimize their billing while still ensuring appropriate reimbursement for the ultrasound procedure.

The panelists also discussed the importance of having a clear understanding of the specific requirements for billing ultrasound procedures. They emphasized the need for proper documentation, including a detailed description of the ultrasound findings, the clinical indication for the study, and the interpretation of the results. Providers should also be familiar with the appropriate CPT codes for ultrasound procedures and ensure that their billing practices comply with all relevant regulations and guidelines.
